# Karen Knutson - demo artist on February 11, 2010 "Starting Traditionally, Moving to Abstraction!"

Karen Knutson will demonstrate on February 11 at the MnWS meeting. The demo will show how to take a traditional subject and make it abstract or at least, semi-abstract. Karen starts every painting, thinking in terms of simple shapes, and good design. How to achieve glowing colors will also be discussed.

"I remember the day that I switched to mainly painting abstract or semi-abstract paintings. A customer had called

to have a private studio visit, and had indicated that she loved my contemporary paintings when talking with me on the phone. But when she arrived for the visit, she went straight to a traditional floral, and my heart sank! I had been looking forward to telling her all about my new abstract paintings, the feelings that arise when I paint them, and how they take on a life of their own. I decided on that day, that from now on, I would paint only what is in my heart, not what happens to be selling." Karen has never regretted that decision. Now, she is better known for her abstracts, and these paintings are the ones that are getting accepted into national juried shows and winning awards!

Teaching began for Karen Knutson in 1988. She thoroughly loves teaching watercolor and collage, and teaches workshops all over the United States. One annual workshop is co-taught with Pat Undis, where they go to Superior Shores in Two Harbors, MN in February. In 2010, this will be the eleventh annual workshop there, and is sponsored by the Edina Art Center. Karen is a signature member of Transparent Watercolor Society of America (formerly known as Midwest Watercolor Society,) Red River Watercolor Society, the Montana Watercolor Society, and the Northern Plains Watercolor Society, the Minnesota Watercolor Society, the Missouri Watercolor Society, and has had many paintings accepted into many other national shows. Her paintings are featured in Splash 6, Watercolor, Fun and Free, and Searching for the Artist Within, Watercolor - The Spirit of Spontaneity, and the magazine, Watercolor Magic (Aug.'04). #### from the President



We had a nice turnout for our Easel Night in December with lots of very fine work on display. Members enjoyed the chance to talk with each other and explore new directions. It is always fun to see how other artists work. At our January meeting we will be having an "Art Swap and Sale." If you have supplies, equipment, frames, etc. sitting around your studio that you are not using, bring them along to the meeting and maybe you can work some trades.

While chatting with members at Easel Night, one comment I heard got me to thinking.

One artist expressed some concern about developing a style. My comment to her was she should not worry about it. A style develops as we grow confident in our medium and as we practice our skills. Style is about expression and that is one of the last pieces that gets put in place. We spend a lot of time learning technique and how to apply the paint, but expression is learning to paint what we feel. When we are comfortable with technique, composition and design, color and perspective and all of those other things we learn, we can finally let go and paint intuitively and our style becomes apparent. I remember being surprised the first time someone mentioned that they could tell it was my painting from across the room. How did they know? Expression is about letting go and letting our feelings take control. Too often in watercolor, we try to maintain control, when being a little out of control might yield better results. It is a scary feeling, but exhilarating at the same time.

The accepted wisdom is that mastery comes after 10,000 hours of practice. Let's do the math here: working 5 hours a day, 5 days a week, it would take about 8.3 years of practice to achieve mastery of a skill. I'm not sure we ever achieve mastery of watercolors, but nevertheless, that kind of practice time put in will generate great results. Students ask me how often I paint and it always strikes me as kind of an odd question. I paint every day. It is a big part of my life and I try to at least pick up a brush and practice a bit each day. It is no different than learning to play an instrument. The harder you work, the faster you get results. If you are painting this much, your skills will develop to the point where you don't have to worry about how to put the paint on the paper, but you will be thinking about what you want to say. Always start a painting with a concept: What is this piece about? What attracted me to this scene? What am I trying to say? This will help get you to the point of being able to express your feelings on paper. Keep this concept in mind as the painting progresses and make sure that everything you do points to this concept.

I encourage you in this new year to engage yourself in your painting, to practice each day, if only for 10 minutes. And before you know it, someone will be saying, "I could tell that was your piece from across the room!"

#### TO ENTER:

Entries must be postmarked by February 5, 2010. Incomplete or unsigned entry forms and forms postmarked after February 5th will be returned. This is a Juried show which is open to all MnWS members in good standing who have paid their dues through May 31, 2010. You may join the Minnesota Watercolor Society or renew your membership by sending a separate check for the membership dues with your entry form and entry fee. Each member may submit two digital entries.

#### **FEES:**

The entry fees are \$20 for the first image and \$10 for the second. This is a non-refundable fee. All entry fees support MnWS exhibitions. Make checks payable to Minnesota Watercolor Society. Enclose a separate check for new membership or renewal dues. \$30 for Singles, \$40 for Couples/Family, \$25 Seniors (65 or wiser).

#### JUROR & AWARDS:

Minnesota Fine artist, award winner and workshop instructor, Greg Lipelt will be our honored judge for this year's show. Awards will be given in the following categories: Best of Show, Emrich/Stordahl Founders Award, First, Second and Third Honors, Awards of Merit, Honorable Mention and People's Choice.

#### TWO ENTRY OPTIONS:

1. Online Entries: You may enter your paintings online! Send your online entry(s) (Two separate painting images) as a photo attachment to <a href="DebMagelssen@Yahoo.com">DebMagelssen@Yahoo.com</a> Mail your Entry Form (with payment) before the postmarked date of February 5th. I will cross reference your email images with your mailed Entry form. Online images and Entry forms both need to be emailed/mailed in before the entry date!

FORMAT FOR ONLINE ENTRIES:

FILE FORMAT: jpeg, highest quality, no compression

FILE SIZE: Images should be no smaller than 900 pixels in the longest dimension. Make image appear appx. 4"x 6" at 300 dpi. (For Printing purposes) FILE NAME: Name your file: Last name, First initial, Title of painting.

IMAGE: The image must be orientated correctly (Vertical or Horizontal). Show only the painting-No frames or mats.

2. Mail a CD: For those who cannot send me photo attachments via email, you can mail me a CD. Please use the same format for online entries to make your CD. Label the CD with a permanent marker: Artist Name. Title(s) of Artwork, Medium and make a printed photo of each entry and include with your entry form. CD's will be kept for 90 days after show ends and will be available at the General Meetings.



SPECIFICATIONS: All paintings must represent Nature in some form to conform with Silverwood's mission of combining Art and Nature.

PLEASE NOTE: Silverwood Gallery will be printing out gallery labels for each painting exhibited and requires that each artist provides information and a brief description of each painting and how it reflects Nature. (This information is for Silverwood Gallery's secretary) The label will be positioned next to your painting during the exhibit and will need to include your Name, Title of Artwork, Medium, "Courtesy of Artist", Price, Description. (In that order). Please email Deb your artist information and description along with your digital entry at <a href="DebMagelssen@Yahoo.com">DebMagelssen@Yahoo.com</a> In email subject title add: "MnWSLabels and Digital Entry" or mail this information along with your CD entry. Paintings may include non-representational art inspired by Nature. Please call Deb at 651-464-5326 if you have questions regarding specifications, frames and mats. Note: Paintings that do not conform to these standards will not be accepted.

#### MATTING AND FRAMING REQUIREMENTS:

- 1. White, Off-White and Light Colored Neutral Mats only. No colored or elaborately designed mats.
- 2. Frames must be simple, sturdy and have wire and hooks mounted 2" from the top of the painting.
- 3. Maximum exterior frame size is 36" x 44" or 80" total (H&W)
- 4. Frame size exceeding 53" (H&W) total must have P1exiglass.
- 5. Recommended: Rubber pads on bottom of corners.



**SALES:** Paintings may be offered for sale or "Not for Sale" (NFS). Silverwood Gallery receives a 25% commission on all sales. Artist receives 75% of sales. All sales will be handled by Silverwood Gallery. Silverwood Gallery will provide contracts for artists who sell their work. Contracts will be available at the General Meetings for all participants. **Insurance and Liability** is not provided by either MnWS or Silverwood Gallery. Each artist is responsible for providing their own insurance.

**DELIVERY OF ARTWORK**: Deliver paintings on Monday, March 8<sup>th</sup> from 5 to 8 pm to: Silverwood Gallery, Visitors Center, 2500 County Road E, St. Anthony, MN You can find directions at <a href="www.ThreeRiversPark.org">www.ThreeRiversPark.org</a> or call 763-559-9000 In extenuating circumstances, members may ship their paintings before March 6th to Deb Magelssen to deliver to Silverwood Gallery. Return shipping/mailing label must be included with shipped artwork. Artwork with no return shipping label will be returned at member's expense.

**EXHIBITION CLOSE AND PICK UP**: Pick up paintings from Silverwood Gallery on Monday, May 3<sup>rd</sup>, 5 to 8 PM. No pickups prior to May 3<sup>rd</sup>. A late fee of \$5 per day will be charged for any painting not picked up.

## **MnWS Signature Status**

What is signature status? Simply put, it is a way to identify and reward sustained excellence of members of an organization. In February of 2008, the Minnesota Watercolor Society (MnWS) launched their Signature Status Program.

**Criteria for signature status:** One must earn six points in a five year span to earn signature status in the MnWS.

#### Here's how you earn points

- One point is awarded for each piece accepted into our spring juried show.
- ▶ One point for any award won in our fall open show or our spring juried show. All awards best of show through honorable mention, including the Emrich/Stordahl award are worth one point. (Exception the people's choice award would not count for a point.) A person can accumulate multiple points in one show (i.e. Sue gets two pieces accepted into the spring juried show and one piece wins an award. Sue would accumulate three points in this situation.)
- ➤ Volunteerism roughly ten hours or more of volunteer time a year equals one point. Examples include serving as board members, conducting workshops, doing membership mailings, editing the newsletter, etc. These jobs are essentially covered in the long list of names listed inside the front cover of our newsletter. Only two points can come from volunteering, the other four points must be earned by artwork in shows. (If you don't have any volunteer points, you can still achieve signature status by earning all of your points through your artwork.)
- ► Only members paid-up in good standing can retain this status.

MnWS after an artist's name denotes they have achieved signature status. Announcements of new signature members will be done as soon as a person earns that status; usually at the fall and spring show openings. Individuals can contact Dianne Jandt at artistjandt@aol.com to find out their total points.

## How to flatten a watercolor

by Phyllis Winther

It is easy to remove wrinkles and buckling from a finished watercolor, and restore its original flatness. Obtain a sheet of 1/8" Plexiglas or a discarded sheet of acrylic and a piece of 3/4" particle board (or something similar). Cut both to a size that is at least 3" larger than your paper. (I have a 28" x 36" flattener to fit a full 22" x 30" paper size or anything smaller). Lay the particle board on the floor and put the Plexiglas on a table with your finished watercolor face down on it. Moisten the back thoroughly with a square synthetic sponge, keeping 1/4" from the paper's edge. Lay the picture dry side up on the particle board and blot any moisture with soft tissue. Cover the painting with dry Plexiglas; then pile books or other weights evenly over the surface, and let it dry for several days. If you use material for the base other than particle board spread old computer paper or paper towels on top before you put the picture on, to insure absorption.
