Hello fellow watercolorists! I am excited to share with you at the May 2012 MNWS meeting. What an honor to be invited to do so. I have been painting for over 30 years with my

greatest passion being in the medium of watercolor. Having taught science in the Hopkins School District and later serving as a Lutheran pastor in Birchwood, Wisconsin until 2011, my full-time work is now as a "Drawn to the Word" artist, where my interests in the arts, science, and theology have merged together. I work ecumenically with churches, colleges, conventions, seminaries, camps, schools, and more, painting murals (up to 12 feet x 5 feet or larger) live before audiences of any size in under an hour during worship services and events. While doing this, I use an "alla prima" approach with acrylic latex (which will behave much like watercolor as water is added). These murals depict stories, mission statements, and themes of choice, usually painted in collaboration music and narration. The mastery of watercolor has been the key which underlies this large-scale mural painting approach. During our May meeting however, I will paint a startto-finish watercolor as a demonstration while also sharing about my approach to mural painting.

Painting the landscape has been my earliest and most profound inspiration due to my upbringing on a farm. With numerous influential people along the way, including my elementary school art teacher who assisted me in painting a watercolor at age 10 for the Governor of Wisconsin when I was selected to represent the state for Youth Art Month in 1979, to people I meet as I teach workshops, to artists of some renown who have helped me to "see" watercolor in new ways, I am grateful. I anticipate that the same will happen as I engage in watercolor with you in May. My hope is to both share insights which will inspire you in your painting, and engage us in a dialogue so we can mutually benefit. See you soon!



### Watercolor Reflections

How many times have you come across a reference picture that has cast a spell on you as the great reference photo for your next painting — only to realize that the actual painting came out a complete flop and fails to "pop?" Yes, we can manipulate exposure, adjust and crop but the essence of success lies in something beyond these adjustments. Today, I will share with you from Frank Eber's blog. Frank is one of the AWS 2012 competition winners. I look for inspiration and check what other watercolor artists are doing and what they are saying in their blogs.

## A Picture Tells A Story ... Not!

Not until you do some 'visioneering.' I have adapted this term from the great watercolor painter Robert Wade, who is in his eighties now but still going strong!

What he means is basically what I preach in my classes as well: Do not just copy the photograph! Being able to paint something as it is, or copy what's on the reference is irrelevant! Treat the Reference photo reference as exactly that, a reference!



The goal should always be to capture the character, a feeling, a mood etc. Only then do we rise to the next level. Not an easy thing to do, but no one said that painting well is easy, right?

The reason I wanted to paint this was the lovely shadow on the building in the late afternoon light. Also, there's not a whole lot going on in this picture, is there? We need to do some visioneering! Add a few figures, some lights and a vehicle and, voilá, we might just have a painting!


Please note that I didn't try to copy the building too closely, yet ironically, it looks a lot like what's on the photograph, doesn't it?

I didn't use any chinese white. Not in any of the lights, nor in any of the dark washes. Texture was achieved by spattering water or pure pigment. The lighter shutters in the dark areas were lifted while the wash was still damp, i.e.

wet. I try to avoid lifting when the washes are dry. To me, it feels too much like 'fixing' things ... but that's just me, if you're happy to lift and use chinese white, go for it. I just prefer not to!

It is the process of creating art that inspires me – how we all bring our different strengths to the table.
